1. Release. The game of soccer can be inherently dangerous. Field conditions, weather conditions, facility conditions, condition of equipment, condition of the registrant, actions of the other players, referees, coaches, spectators, volunteers, event officials or monitors can all create risks of accident or injury. The undersigned is aware of these risks and assumes all responsibility for the registrant. THE UNDERSIGNED, ON BEHALF OF THEMSELVES AND THE REGISTRANT IF A MINOR, HEREBY RELEASE, WAIVE AND DISCHARGE DAFC (Bend FC Timbers), THEIR BOARD OF DIRECTORS, OFFICERS, COACHES AND VOLUNTEERS, AND AGREE TO INDEMNIFY THE SAME, FROM ANY AND ALL LIABILITIES, CLAIMS, DEMANDS OR CAUSES OF ACTION OF ANY KIND FOR ANY LOSS, DAMAGE OR INJURY, HOWEVER ARISING, RELATING TO OR ARISING OUT OF ANY DAFC (Bend FC Timbers) ACTIVITIES, INCLUDING LIABILITIES OR CLAIMS FOR LOSS OR DAMAGE ARISING OUT OF THE NEGLIGENCE OF DAFC (Bend FC Timbers), THEIR BOARD OR DIRECTORS, OFFICERS, COACHES AND VOLUNTEERS.
2. Consent for Medical Treatment. The undersigned certifies that the registrant is in good physical condition and the undersigned has no knowledge of any physical condition, injury, or illness whatsoever that would place the registrant at risk to participate in DAFC (Bend FC Timbers) Activities. The undersigned consents to emergency medical care prescribed by an EMT or other first responder, a duly licensed Doctor of Medicine or a Doctor of Dentistry. This care may be given under whatever conditions in the good faith judgment of DAFC (Bend FC Timbers) staff or volunteers are reasonably necessary to preserve the life, limb or well-being of the registrant.
3. Code of Conduct. The undersigned (on behalf of themselves and the registrant if a minor) agree to abide by all rules of DAFC (Bend FC Timbers) and its affiliated organizations and sponsors. Additionally, the undersigned acknowledges that they have received, read, understand and agree that family and guests will fully abide by the Parents Code of Conduct published by DAFC (Bend FC Timbers.) The undersigned will insist that the registrant play in a safe and healthy environment, and will promptly remove the registrant from any situation where there is any question as to safety or health.

5. No Modification of Terms. No one is authorized by DAFC (Bend FC Timbers) to alter, modify, or waive any of the terms of this agreement in any way.
